I) Eligibility Criteria for Admission:

- A) Candidates having a Master's degree or a professional degree declared equivalent to the Master's degree by the corresponding statutory regulatory body with at least 55% marks in aggregate or its equivalent grade 'B' in the UGC 10-point scale (or an equivalent grade in a point scale wherever grading system is followed), M.Phil. Degree of Indian institutions or equivalent degree from a foreign educational institution accredited by an Assessment and Accreditation Agency which is approved, recognised or authorised by an Authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational institutions.
- B) A relaxation of 5% of marks, from 55% to 50%, or an equivalent relaxation of grade, shall be allowed for those belonging to reserved categories/Differently-abled and other categories of candidates as per policies of the Government of Maharashtra prescribed from time to time, or for those who had obtained their Master's degree before 19th September 1991. The eligibility marks of 55% (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible based only on the qualifying marks without including the grace mark procedures.
- C) M. Phil. students of any recognised University whose M.Phil. dissertation has been evaluated and the viva voce is pending may be admitted to the Ph.D. programme.

II) Process of Admission: -Candidate shall be admitted to Ph.D. programmes by a two-stage process through:

- A) Entrance Examination**
- B) Personal Interview**

A) Entrance Examination:

- a) H-PET Entrance Examination, which shall be a qualifying text.
- b) The test H-PET comprises two Papers:
 - Paper I :- Research Methodology and Research Aptitude: 50 Marks
 - Paper II :- Subject Specific: 50 Marks
- c) The H-PET shall carry 100 Marks for the duration of 2 hours.
- d) Qualifying marks shall be 50 % of the aggregate, taking Paper I and Paper II together.
- e) All questions shall be multiple choice; each correct answer carries one mark with no negative marking systems.
- f) Relaxation of 5% of Marks, from 50% to 45%, shall be allowed for those categories of candidates as per policies of the Government of Maharashtra prescribed from time to time.

B) Personal Interview:

For candidates qualifying in H-PET and Candidates exempted from the Entrance Examination, a personal interview will be conducted as per the procedure prescribed in due course. (www.hsncu.edu.in)

III) Exemption from appearing in Entrance Examination: H-PET

The Candidates fulfilling at least one of the following conditions will be exempted from the Entrance Examination:

- A) Candidates qualified in UGC-NET (Including JRF) / UGC-CSIR NET (Including JRF) / SLET/ SET / GATE (valid score) / GPAT (valid score), CSIR / ICAR / ICMR / DBT & DST Inspire fellowship / Joint Graduate Entrance Examination for Biology and Interdisciplinary Life Science (JGEEBILS) or Teacher fellowship holders will be exempted from the Entrance Test.
- B) Students who have passed the PET examination conducted by any recognised University.
- C) Candidates who have passed M. Phil. Programme from any recognised University will be exempted from the Entrance Test for the Ph.D. programme, provided the MPhil is as per UGC guidelines.
- D) Ph.D. degree holder from any recognised University who desires to pursue Ph.D. at this University.

- It is the responsibility of the applicant to fulfil the eligibility conditions and comply with the admission requirements. If at any stage it is noticed that the candidate or important material facts have made a false claim, has been concealed and / or the candidate is not eligible, his candidature shall be liable for cancellation at any stage.
- In case of any grievance or dispute, the decision of the University shall be final and binding on all.
- Candidates need NOT submit printouts/hardcopy of applications or documents to the University after completing the online application submission. However, it is necessary to carry the original documents at the time of the Personal Interview.
- Application forms submitted after the due date or incomplete application forms without uploading required documents will be rejected without assigning any reason. The University will not entertain any correspondence in this regard.
- The request for change in any information submitted in the online form will not be considered.
- The online registration process will be treated as complete only after the required certificates and application are uploaded on the link provided.

1. H-LAT – HSNC UNIVERSITY LAW APTITUDE TEST GUIDELINES

H-LAT Entrance exam is the qualifying examination for admission to the 3 Year LL.B. Program, 5 year Integrated Programs i.e. B.A. LL.B. and BB.A. LL.B. (Hons.) offered under HSNC University, Mumbai

1.1 Eligibility for LL.B. 3 Year Law Program:

Graduates/postgraduates with Bachelor's / Postgraduate degree with at least 45% marks or equivalent grade for General Category candidates, 42% marks or equivalent grade for SEBC/OBC category and 40% marks or equivalent grade for SC/ST category candidates in any discipline (e.g. Engineering-Technology, Science, Commerce, Management, Accounts, etc.) from any university recognized by UGC/ AICTE / AIU or equivalent are eligible to apply. However, there is no age limit to apply.

Fresh Graduates/postgraduates awaiting final result declaration can also apply and appear for **H-LAT**. The qualified and shortlisted candidates will be provisionally admitted.

1.2 Eligibility for BB.A. LL.B. (Hons.) / B.A. LL.B. 5 Year Integrated Law Program:

Passed 10+2 (HSC) XII standard or an equivalent examination from any recognized Board with a minimum of 45% marks or equivalent grade for General category candidates, 42% marks or equivalent grade for SEBC/OBC category candidates and 40% marks or equivalent grade for SC/ST category candidates in any stream (i.e. Arts, Science or Commerce, etc.) from any institution recognized by UGC/ AICTE / AIU or equivalent are eligible to apply. However, there is no age limit to apply.

Candidates awaiting XII standard result declaration can also apply and appear for **H-LAT**. The qualified and shortlisted candidates will be provisionally admitted.

Selection Criteria:

- CLAT (Common Law Admission Test);
- LSAT (Law School Admission Test); and
- MH-CET Law (Maharashtra Common Entrance Test Law) scores may be considered.
- The aforesaid scores should be current and valid.

Candidates not having any of the above scores will be required to appear for H-LAT. In case of multiple test scores, a candidate can submit his or her best score. Candidates can also appear for the **H-LAT** to improve their Test Score. HSNC University, Mumbai will prepare a scale for comparison of Test Scores conducted by various agencies mentioned above. Such details will be placed on the admission brochures, material and HSNCU website in a fair and transparent manner.

H-CET Guidelines

HSNCU Common Entrance Test (H-CET) is the qualifying examination for admission to the Two Years Master of Business Administration (MBA) and Three / Four Years Bachelor of Business Administration (BBA) / Bachelor of Management Studies (BMS) / Bachelor of Computer Application (BCA) Programmes offered under HSNC University, Mumbai. H-CET will be conducted ONLINE.

1. Eligibility:

A. **MBA:**

- i. Graduates/postgraduates with Bachelor's / Postgraduate degree with at least 50% (for General Category) and 45% for Reserved and Physically / Differently abled candidates in any discipline (e.g. Engineering-Technology, Science, Commerce, Management, Accounts, etc.) from any university recognized by UGC/ AICTE / AIU or equivalent are eligible to apply.
- ii. The percentages may be relaxed for the candidates from the Armed Forces or their children.
- iii. There is no age limit for applying.
- iv. Fresh Graduates/postgraduates awaiting final result declaration can also apply and appear for **H-CET**. The qualified and shortlisted candidates will be provisionally admitted.

B. **BBA/ BMS / BCA:**

- i. Passed 10+2 (HSC) or its equivalent examination (As per AICTE APH 2024-2027)
- ii. Candidates appearing for 10+2 (HSC) or its equivalent examination are also eligible to appear for **H-CET**

2. Selection Criteria:

- A. CAT, XAT, GMAT, C- MAT, MAT, SNAP, MH-CET or any State CET scores may be considered. The aforesaid scores should be current and valid.
- B. **Candidates not having any of the above scores will be required to appear for H-CET. In case of multiple test scores, a candidate can submit his or her best score.** Candidates can also appear for **H-CET** to improve their Test Scores. HSNCU will prepare a scale for comparison of Test Scores conducted by various agencies mentioned above. Such details will be placed on the admission brochures, material and HSNCU website in a fair and transparent manner.
- C. Appropriate weightage will be given to various selection criteria, including: scrutiny of application forms, test scores, group discussion, written essay and personal interview.

H-LAT-2 – Guidelines

H-LAT-2 Entrance exam is the qualifying examination for admission to the 2-year LL.M. Program offered under HSNC University, Mumbai

1. Eligibility for LLM Program:

The eligibility criteria for admission to LL.M. (Two-Year) Degree course shall be as follows:

- (a) The minimum qualification for a candidate making an application for admission to the LL.M. Degree Program offered by HSNC University is LL.B. degree (3 year or 5 year) of HSNC University or any other Indian or Foreign University recognized as equivalent by HSNC University.
- (b) For General Category LL.B degree (3 year or 5 year) with at least 45% marks or equivalent grade, for SEBC/OBC category 42% marks or equivalent grade and for SC/ST category candidates 40% marks or equivalent grade.
- (c) Candidates who have appeared for the Final Semester Examinations of 3 year or 5-year
